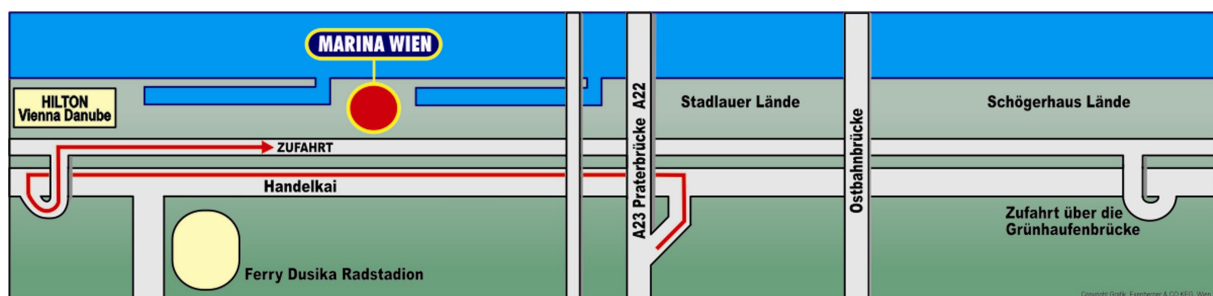

Way to Vienna / Marina Wien

Take the highway **A1/E60** to Vienna, by the crossing “Steinhäusl” keep right and follow the highway **A21/E60** to the crossing “Vösendorf”, there keep left and follow the direction **A23/E59** to Vienna. Leave the highway **A23/E59** at the exit Handelskai, by the **second** traffic light turn left and go along the Handelskai in the north-west direction. On the Handelskai, you will see the signs to “Marina Wien”.
